## PLEASE READ BEFORE SIGNING

If, however, I observe any significant hazard during my presence or participation, I will remove myself from participation and bring such attention to the nearest manager, employee, or parent immediately; and,

I have read this release of liability and assumption of risk agreement, fully understand its terms, understand that I have given up substantial rights by signing it and sign it freely and voluntarily without inducement. I also acknowledge that I have had the opportunity to have this document reviewed by an attorney, consult with an attorney, and/or obtain the advice of an attorney prior to executing this document. This agreement and release of liability shall remain in full force and effect as long as the below stated Participant participates in the Club.
