PARENT/GUARDIAN WAIVER AND RELEASE OF LIABILITY AGREEMENT

PLEASE READ CAREFULLY. THIS IS A LEGAL DOCUMENT THAT AFFECTS YOUR LEGAL RIGHTS.

1. Assumption of Risk

I understand and acknowledge that participation in youth sports involves inherent risks, including but not limited to physical injury, illness, property damage, permanent disability, or death. I voluntarily assume all such risks, whether known or unknown, and accept full responsibility for my child's participation in the Activities.

2. Release and Waiver of Liability

To the fullest extent permitted by law, I hereby release, waive, discharge, and covenant not to sue BK Sports Management LLC, its owners, officers, directors, affiliates, agents, employees, volunteers, successors, and assigns (collectively, the "Released Parties") from any and all liability, claims, demands, causes of action, or losses, including but not limited to those related to personal injury, illness (including communicable diseases such as COVID-19), property damage, or death, arising from or related to participation in the Activities.

3. Coaching Staff – Independent Contractors

I understand and acknowledge that all head coaches and assistant coaches affiliated with the Organization are independent contractors and are not employees, agents, or legal representatives of BK Sports Management LLC. The Organization does not control or direct the manner or means by which coaches provide instruction or manage their teams.

The Organization is not responsible for any acts, omissions, conduct, decisions, or interactions by or involving coaches, including but not limited to team selection, playing time, disciplinary action, or coaching style. Any concerns regarding a coach's behavior or decisions should be addressed directly with the coach or, if necessary, escalated through the proper communication channel established by the Organization.

4. Coach Qualifications

All head coaches have successfully completed:

- A criminal background check,
- Concussion awareness training,
- Heat illness prevention training.

While these safeguards are in place to help ensure a safe environment, the Organization cannot guarantee the conduct or performance of any coach.

5. Medical Authorization

In the event of an injury or illness to my child during participation in the Activities, I authorize the Organization and its representatives to seek and secure emergency medical treatment as deemed necessary. I agree to be fully responsible for any costs associated with such treatment.

6. Photo/Media Release

I grant the Organization the right to take photographs, videos, and other media of my child during Activities and to use them for promotional, marketing, or educational purposes in print and online media without compensation or notice.

7. Governing Law

This Waiver shall be governed by and construed in accordance with the laws of the State of Oklahoma. Any legal dispute arising from this agreement shall be brought exclusively in the courts of Tulsa County, Oklahoma, or the federal courts sitting in the State of Oklahoma.

8. Acknowledgment

I have read this waiver in its entirety. I understand that by signing below (or electronically acknowledging during registration), I am waiving certain legal rights, including the right to sue the Organization or its representatives.
